filed within the time prescribed by law as in fact it was embodied in the same resolution exonerating you from office. There is no doubt that the municipal president, is a party interested in the proceedings. The filing of the appeal by him is therefore in order.

There is no prescribed form established by law for the filing of an appeal under said section 2272 of the Administrative Code, as amended by Act No. 3206. The law simply states that the appellant shall exercise this right by filing with the municipal president a written appeal within 15 days from the date he has been notified of the decision. The fact that the appeal was embodied in the resolution of the municipal council and signed by other members of said council did not vitiate the appeal.

In view of all the foregoing considerations, your requests can not be given due consideration.
