The owners shall also be liable for the damages caused:

"1. By explosion of machines which have not been cared for with due diligence, and by the combustion of explosive substances which have not been kept in a safe and proper place.

"2. By excessive smoke, which may be noxious to persons or properties. x x x (Art. 1908, Civil Code).

Everything that endangers life or health, gives offense to the senses, violates the laws of decency, or obstructs the reasonable and comfortable use of property is a nuisance. (20 R.C.L. 390). Any act, occupation, or structure which is a nuisance at all times and constitutes a direct menace to the public health or safety is a nuisance per se and may be abated summarily under the undefined law of necessity, while those which become nuisances by reason of circumstances and surroundings, are nuisance per accidens and may be abated after due hearing in the courts of competent jurisdiction. (43 C. J. 613-649).

"3. Although not specifically penalized by existing laws, the emission of noxious gases or offensive odors in such quantities as to injure the health of materially interfere with the comfort of the public and those produced by smelting works, which cause in-
