Gentlemen:

By virtue of the authority vested in me by the Revised Administrative Code, I have the honor to call for **REGULAR MEETING**, to be held on the second Saturday of June 14, 1941, at 5:00 P.M., to treat the following matters of vital importance:

1. Appropriating the amount of ₱ 600 from the part of five per cent (5%) unappropriated reserve fund for the creation of temporary laborers at the rate of compensation of ₱1.00 a day, needed to assist the works, such as filling the forms for enlistment, filing the records in numeral and alphabetical order, etc. of Volunteers Guards.
2. Resolution petitioning the Hon. Secretary of the Interior that a constabulary barrack be returned to the former place along the National Road, on the land and buildings owned by the San Carlos Milling Co., Ltd., in this town, for the reason that during the time that the constabulary detachment was taken from this place, having about seventy thousand inhabitants, to many serious crimes involving afflicted penalties have been committed by criminal minded people.
3. Appropriating the amount of ₱ 250 for the purchase of additional fire fighting apparatus as suggested by the provincial Inspector, P.C., Major Montilla, in consonance with the provision of Article 2278 of the Revised Adm. Code.
4. Appropriating the amount of ₱ 150 from the general fund for the purchase of two-28 caliber and 1 thirty eight caliber revolvers for the use of the members of the police force of this municipality. These 2-twenty caliber revolvers are needed for the target purposes in an economical way.

Other matters of vital importance.




