MEMORANDUM to:  
Lieut JULIUS V. PRESUTTER, JAG  
Staff Judge Advocate, 76th Inf  
(Thru CO, 76th Infantry)

1. On 13 January 1945, a communication was sent to you, thru the CO, 76th Infantry, of the following tenor:

"In view of the great number of prisoners now detained in the Detention Cell, 1st Bn., 76th Infantry, you are hereby directed to proceed at once to the temporary headquarters of the JAGs, 72D at Alingasse.

A communication has been addressed to the CO, 76th Infantry, for the temporary services of Sgt. Arrez and you are directed to make arrangements in order to avail of the temporary services of Sgt. Arrez.

Make every effort repeat every effort to secure the necessary stationery that shall be needed in the course of investigations you shall undertake, especially carbon paper and typewriter ribbon."

2. Unless the CO, of the 76th Infantry, shall advise you there is desired that you immediately proceed to the temporary Office of the JAGs, at Alingasse, from Alingasse upon receipt of this Memorandum.

3. Bring with you all documents, exhibits, etc., which have any connection either directly or indirectly with the cases against the prisoners now confined in the Detention Cell of the 76th Infantry.
