SUBJECT: Certificate of Municipal  
 Treasurer Required to Support Vouchers  
 Covering Repair of Artesian Wells


TO ALL MUNICIPAL TREASURERS & DEPUTIES  
 PROVINCE OF NEGROS OCCIDENTAL, P. I.

For your information and guidance, there is transcribed hereunder the letter, dated August 19, 1935, of the Provincial Auditor regarding vouchers covering repair of artesian wells:

"Effective September 1, 1935, it is requested that all vouchers covering repair of artesian wells be supported by certificates of the Municipal Treasurer concerned stating the number of men employed for the repair and the number of days it took them to do the work. If the artesian wells are in the barrios, the certificate of the barrio lieutenant will serve the purpose, in case the Municipal Treasurer can not send his representative thereat.

"This step is necessary for the protection of both the laborers who do the repair and the Municipal Treasurer who makes final payment for the work done. - Respectfully,  
 (Sgd.) P. F. SISON, Provincial Auditor".

Effective September 1, 1935, Municipal Treasurers should issue the person in charge of the repair of the artesian wells in their respective municipalities the certificates referred to in the above quoted letter of the Provincial Auditor and should see to it that in the payment of vouchers covering repair of artesian wells, there are attached to said vouchers the required certificates.
