- c. REPLACEMENTS: Arrival of 600 Nipa Troops as of 22 Nov. 44 and 250 Nips of Kase Butai as of 23 Nov. 44 via Banago shows another Nips Infantry unit in the City. The sending out of reinforcements by the Nips in the City to their garrison in the towns threaten by friendly troops in this islands shows slight decrease in the Nips strength in the City.  
The present quarters and disposition of the new arrival of Nips troops is still under close verification.

## d. COMPOSITION: Bacoled &amp; Suburbs:

1. There are presently three (3) incomplete Infantry Regiments present in the City. However attached units, composition of which is still unknown, are present in the City.

Sum-ag -- One Company (Infantry)

Vista Alegre -- One platoon & 3 squads (Infantry)

Murcia -- one Platoon & one squad (Infantry)

## e. ARMAMENTS: The Yamaguchi and Hoxi Butai - No change.

The Kase Butai which arrived in this Area recently were noted that some of their soldiers are armless. Some were equipped with arisaka rifles. Their automatic weapons are still under verification.

## f. OFFICERS &amp; NCO: Name of Officers and NCO of the Kase Butai is still unknown as this troops disposition at present could not be ascertained.

## g. DEFENSE INSTALLATIONS

1. Type & degree of organized field works-- None observed.
  2. Shelter & Tunnels -- No new construction. Same installation as reported.
  3. Gun emplacements: No new emplacements observed.
  4. Communication lines: No change.
  5. Observation posts: No change.
- A Defense installation: No new emplacements noted.

**H. ENEMY UNITS:** The Kase Butai and new arrivals of Nips, their training and tactics employed is yet unknown. The Yamaguchi Butai as observed in series of operation made by friendly troops performed the do-or-die tactics.

**I. MORALE:-**

- 1. **Combat Value:-** The enemy's morale is high and applied to warfare they adhere to the do-or-die tactics.
- 2. **Esprit de Corps:-** Excellent, as observed from Nips troop this spirit of cooperation and mutual understanding infuse in them since their training & entry into the Nips Army.
- 3. **Desertion Rate:** None
- 4. **Health:-** The diminishing stock of medicine in this area shows improper supply of medicine for Nips individual soldier. However, the daily exercise maintained by the Nips makes them vigorous and healthy.
- 5. **Rations, quality, & sufficiency:** The Nips as observed during this period have been resorting to eating root crops as substitute for rice but their supply for cereals is very adequate. Economy among the Nips is being emphasized as thereby their food storage will last them up to January 45, whereby they could start foraging patrols by December, 44.
- 6. **Adequacy of Clothing:-** Nips formerly stationed in this Area are clothed with their usual uniforms with patches and stitches and the new arrivals of Nips were found to be wearing civilian clothes.
- 7. **Relation between officers & Men:-** Superiors are well respected but individual Nips soldiers are subjected to harsh treatment by their officers.

**J. MATERIAL & SUPPLY:**

- 1. Nips material & equipment has been noted to be brought along by motorboats from Manila to Bacolod under cover of darkness.
- 2. No new hideout or dumping places noted but wherever the Nips unit move-out they tag along with them their supplies and materials.

**K. ADMINISTRATIVE ELEMENT:**

- 1. **Nips Internal Affairs:-** Ever since the invasion of this Isd and the Nips have absolute control of the government. The civil puppet authorities were given due power (limited), but with the declaration of Martial Law, the government was then placed under their hands.
- 2. **Commerce & Industry:-** None Significant. Nil and Standstill.
- 3. **Economics:-** Buying & Selling of war materials practically of no account and mostly they resort to the purchases of cereals and foodstuffs.

**L. ACTIVITIES:**

- 1. **Ground Operations (Refer to tabulated list attached)**
- 2. No active ground patrols observed. Only limited patrols to vicinity of garrison were observed during this period.

**M. CONSTABULARY:**

- 1. No significant activity noted in this organization. The personnel of this unit was wholly confined to maintaining peace and order inside the city. The JCS are not armed in spite of the repeated request of the Senior Inspector re-arming the JCS.

The morale of our soldiers is indeed very high due to the unceasing allied activity not only in our island but also throughout the Philippines and the entire war fronts. The Allied landings in Leyte, Samar and several small islands have caused excitement and have raised the morale to a high pitch which is too hard to describe.
10. CIVILIAN POPULATION:
  - (a) Status of Evacuation:
 

Many of the civilians from the occupied areas have evacuated far from the enemy military installations outside of our restricted zones. Some of them have already begun tilling the soil left idle while others engage in trading for their livelihood.

Many of the evacuees live with their relatives or friends. As noted some have already constructed houses of their own. Still many are under construction.

The evacuation of our loyal civilians in free areas remains unchanged.

The most common sickness now prevalent among them are beriberi, common cold, tropical ulcer and others malaria.

So far the civilians in the occupied and unoccupied areas have high faith in our Organization.
  - (b) Unusual Events: The daily presence of the allied planes bringing untold miseries to the enemy is already a common sight. Allied bombing and strafing of the enemy and their military installations is just but a daily routine.
  - (c) Incident to Control and Administration: Civilians Administration is under the Civil Government.

To break the monotony of mountain life, this Hq. has resorted to holding Sunday programs in the form of radio news broadcast and dances, attended by representatives of the different batteries and loyal cooperative civilians especially of the

fair sex who always make the affair a lively one. As observed our men prefer to stay in their present station rather than going to Maricao to attend the Weekly Program conducted by Higher Hq but to long distance hike and rugged trails.

Everybody has high hopes and faith of the Allied Victory which is soon to come especially that the Japs now are starved, pecked and driven to the interior of the jungle somewhere in the mountains of Silay. On the other hand, each and every one is very anxious enough to return to his respected home in the lowlands where peace abide but this can only be accomplished when the enemy remnants are exterminated.

10. CIVILIAN POPULATION:

(a) Many civilians in our area have returned to their respective towns as they were but only evacuees. However, bona fide civilians have remain in place. Our transfer to this area have elevated their faith and confidence of security.

No change but with the liberation of most towns from the hands of the enemy, offices of the Civil Government are being transferred. Re-organization of the different departments and branches of the Civil Government is now in full swing.

The morale of a majority of the soldiers of this Command has considerably lowered despite improved living and food facilities and the increased flow of all other items of Army Supplies. It is great bulk of the less illuminated soldiers who do not fully understand their stand and their indisposability as defenders and Upholders of the Democratic way of Living.

However, a selected few still have the stamina to stick to our organization and give their service unselfishly.

10. CIVILIAN POPULATION:

(a) Many civilians have forsaken the mountains now due to the presence of Jap stagglers and foraging parties - but quick to follow behind our troops in any move to go after the enemy mountain-ward. They have the ultimate confidence now in our integrity as fighters - unlike the unorthodox way in " Times Past ".

(b) Unusual Events : Our change of position to the Binitan area has greatly bolstered our reputation since the greatest number of enemy killed was credited to us.

(c) Incident to Control and Administration :

1. 2 June '45 - attached to the 76th Inf tactically to cover the right-most element (Right Flank) of the Filipino Forces aiding the 40th Division in the operation against the Jap hide-out there.

2. 24 June '45 - Three Companies of the 72 Engineer Battalion were attached to our Unit to increase our force in the Binitan sector.
