



8. The garden day cooking exhibits should be of a better balanced diet with plenty of green leafy vegetables.
9. The pupils should not be made to drill and practise on what they already know well enough for their age and grade.
10. The use of good color harmony should be emphasized whenever occasion calls for it.
11. The needlework and cooking classes should stress quality rather than quantity.
12. The finished garments should not be kept for long in the apardor, but they should be worn by the owners after they are scored and graded by the girls.
13. The teacher should be encouraged to give more attention to the everyday things of life.

HEALTH EDUCATION

It is suggested, therefore, that supervising teachers and principals exercise the greatest care both in selecting teachers to attend this institute and in selecting the courses to be taken by the teachers. The recommendations of the supervising teachers should be final as far as both they and the teachers are concerned.
