Problem: I to learn how lumber is cut & how to recognize the cut in some materials: diagrams. School furniture. sections of woods from the house of Godfrey.

Note: Most lumber is cut tangentially. the grain of wood is made by the fibers not taking straight lines in their course in the tree trunk. In many cases the fibers of the wood take a spiral course up the trunk, or they may curve outward to form a little projection.




