




November 5, 1940

For your information and guidance, I have to quote hereunder the following Rulings issued by the Bureau of Internal Revenue, viz:

"**MERCHANT'S SALES TAX.**" If "B", a retailer, desires to have his shirts, pajamas, etc., manufactured by "C", a manufacturer, with "B" furnishing all the materials and supplies while "C" furnishing only the labor, "B" will be subject to the percentage tax of 3-1/2% prescribed in section 186 of the National Internal Revenue Code on his gross sales of shirts, pajamas, etc., manufactured for him by "C". (Ruling, B.I.R. No. 105.02, April 2, 1940).

A sawmill owner who is at the same time a building contractor is not liable for the payment of the percentage of 3-1/2% on the gross value of lumber manufactured or sawn in his sawmill which are used by him in connection with the construction of buildings wherein the contract calls for the furnishing by him of labor and materials. However, he is subject to the percentage tax of 1-1/2% on his gross receipts from the construction of building which includes the value of the said materials. (Ruling, April 16, 1940, B.I.R. No. 105.084).

A person engaged in the manufacture of vinegar without any chemical process but by natural fermentation, is not subject to the manufacturer's fixed and percentage taxes imposed under the provisions of the National Internal Revenue Code. (Ruling, May 20, 1940, B.I.R. No. 105.1).

The so-called newspaper agents and their agents who purchase newspapers from newspaper publishers and re-sell the same at a profit, that is, at prices exceeding the price printed on the paper, are considered merchants, subject to the graduated annual fixed tax prescribed in section 186 of the National Internal Revenue Code. (Ruling, June 20, 1940, B.I.R. No. 105.02).

A person who gets newspapers from the publishers in Manila and sells the said newspapers thru newsboys who gets as compensation P0.03 per copy of the papers which are sold, one-half of which goes to the newsboys, is neither a commissioner nor a merchant subject to the payment of the merchants' sales tax. (Zacarias Corolla, vs. Collector of Internal Revenue, Supreme Court, G.R. No. 46744, June 20, 1940).
