

The period of ninety days prescribed in section 382 of the Administrative Code of 1917 from the publication of the notice provided in section 378 having elapsed and the said real property not having been redeemed in accordance with section 377 of the same Code, you are hereby requested to eject forthwith from said property and keep therefrom all persons having or claiming ownership thereto, or title therein, as well as all tenants, or occupants thereof, and to notify them and all persons so ejected that the owner or his legal representative, or any person having a lien on or lease of said land may redeem the same by paying therefor the full amount due for taxes, penalties and costs, together with an additional penalty of ten per centum upon the whole, provided that the property has not been sold or leased to a third party in the meanwhile. In case the property has been leased or the Director of Lands has entered into a contract for the lease thereof, repurchase may be made subject to such contract.
