Court, the said accused, without lawful authority, did then and there wilfully and criminally clear, with the purpose of making cañgin, approximately One hectares of the public forest, and as a result thereof 100.00 cu. m. of logs 255.00 cu. m. of 4th gr. logs growing therein were destroyed, the double government charges on such forest products so unlawfully destroyed being 210.00 pesos SHIRY-BEYER & 90/100 pesos (P. 300.00).
