Curuan, Zamboanga

1. Last Dec. 28, 1943 I went to a patrol for feeding to tingultingulan. The following morning I went to Muti for the same purpose. On account that Meros of this place were denying that they have no supply at all for the Army, I went to the extreme of searching the house of Jalu (Mero). When I arrived to the house of the said mero I ask for permission if I could get up in their house. A woman and a man gave me the permission to get up. When I was up in the house I asked them if there a some palay for voluntary contribution or for sale. They respond that they have none at all. I told them I am not going to get any grain without paying the quantity I'll get. But still they refused me. Under the house there were hips of palay so that I was made to suspect that this house has plenty of palay. So I asked there permission to take a look inside the house. The people in the house gave me the permission concerning this matter. Before getting in side the sala of the house I called for the man to accompany me in verifying if it's true that there is no palay.

2. When I was inside the sala of the house the very fellow I called to accompany went to a bad intention in grabbing a barong under the mat. Luckily I was on guard so that I got him. At once I took a look under the mat. I found two barong without scabbard, one barong under a law a bench and one spear by the side of the wall. I took hold of this arm and continue my mission. I saw six big bayones with two cavans of palay every bayon and five small bayones. So I asked them why they were denying of not having palay at all. When I finished I went down and proceed home.




