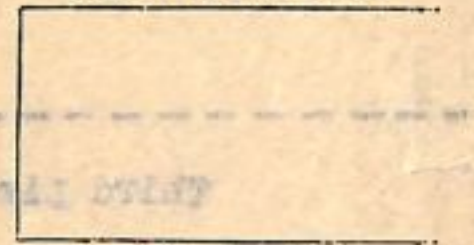



ONE ADDITIONAL GUARANTOR REQUIRED ON B. E. FORM 46, "PUPIL'S RECEIPT AND GUARANTEE-RENTAL SLIP FOR RENTED BOOKS"

To Division Superintendents:

1. The following portion of a 7th indorsement of the Honorable, the Auditor General, is hereby quoted for the information and guidance of the field:

... in order to safeguard the interests of the Government as contemplated in the law ... This Office believes that at least one additional guarantor should be required besides the parents of school children to whom the books have been rented.

2. In view of the foregoing, one additional guarantor besides the guardians or parents of the pupils shall be required on B. E. Form 46, "Pupil's Receipt and Guarantee-Rental Slip for Rented Books." However, where the parent or guardian cannot be easily reached by the pupil because he lives far away, the pupil's signature and that of one guarantor other than the guardian or parent may be accepted. B. E. Form 46 may be continued to be used by putting another line for the signature and address of the additional guarantor on the space provided for the guarantor.

3. This Circular amends paragraph 2 of Circular No. 9, s. 1935, in so far as the number of guarantors required is concerned.

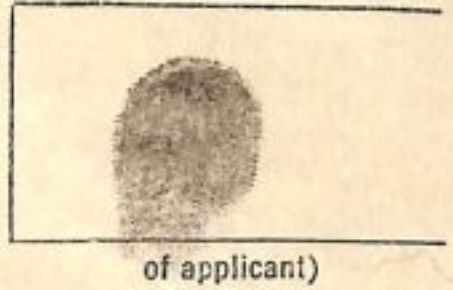

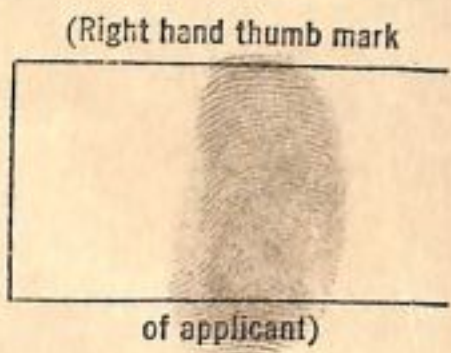

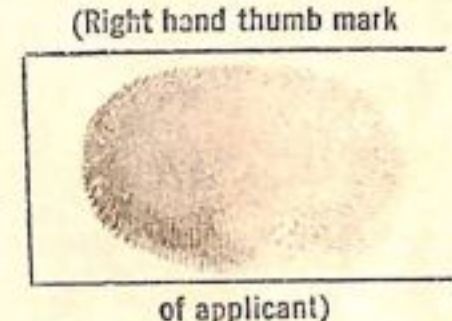

I, Sgt. Marcellano Olario, P.C., a resident of Dipolog, Province of Zamboanga, P.I., after having been duly sworn on oath according to law, depose and say:

That on the 7th day of October 1931 at about 10:30 a/m. I recievd an instruction from the Commanding Officer, 1st Lt. Justino Teñio, P.C., thru ex-Sgt. F. Rivera to look after the stolen shoes from the store of Sy Beng Sian of Dipolog, Zamboanga.

That there was suspicion to several persons boarding in the house of one Petra Postaliño of Miputak. The suspected ones were interviewd and investigated one after another.

After the investigation it was found out that same persons had taken the shoes. Then I, and Pvt. Parangan followed them to their boarding house and Remigio Baldueza and Eleuterio Jamito were requested to show us their maleta and their shoes. One pair of shoes was found on the floor, the other inside the maleta of Remigio Baldueza and the other one was found in the possession of one Serapio Perez using them and told that he only barrowed them from one Eleuterio Jamito.

One of the owners of the shoes made the identification and found out that same were from their store.
